\$ Saving Opportunity

We have a way to help you save you money on your car insurance, and you don't have to switch to GEICO.

Concord Police has agreed to put marked and unmarked police cars in our neighborhood. During some recent electronic monitoring, over 50 tickets would have been written. There is a sign on Moreland Wood Trail noting this area as a traffic enforcement area.

On Moreland Wood Trail, there would have been 11 speeding tickets between 5pm -8pm; from 8pm -11pm there would have been 6. Most shocking was that between 10am - 3pm there would have been 52 speeding tickets. The 85th percentile showed a speed of 31mph

On Monticello, 32 people would have received speeding tickets. One car was clocked at 43mph at 5:45am.

If you see someone speeding, get the tag number and description. Call the police at 704 920 5580.

Drought Restrictions:

Concord customers are always permanently under water restrictions. The City does this by having tiered water rates that penalize those who excessively use water.

Failure to abide by the restrictions will result in a \$100 utility fee for residential customers and higher for other users. Continued disregard of the mandatory restrictions will result in higher fees or even discontinuation of water service.

We are in Level III mandatory water use restrictions. These restrictions went into place at 8 AM on Thursday, September 27, 2007. The mandatory restrictions include:

- No irrigation. All watering and irrigation of lawns is prohibited. Lawn watering and the operation of any sprinkler system are prohibited at all times.

- Handheld containers may be used to water ornamental plants, trees, and gardens. Handheld hoses with spring loaded nozzles may be used to fill containers but not for irrigation purposes.
- Planting of new ornamental plants and seeding of lawns should be deferred until the water emergency no longer exists.
- Recreational use of potable water including filling pools is prohibited. Topping off is acceptable.

- The operation of ornamental fountains (without fish) is not allowed.
- Use of water for wash down of outside areas is prohibited except for pressure washing businesses with an appropriate privilege license. These businesses will ensure that waste of water does not occur.
- Residential washing of cars and other vehicles is prohibited
- It is encouraged that faucets should not be left running while shaving, brushing teeth, or washing dishes.
- The use of clothes and dishwashers should be limited if possible and these units should be operated with full loads when used.
- The use of flow restrictions and other water saving devices is encouraged.
- Showers used for bathing & be limited to four (4) minutes or less.
